If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible. <p>Are there services covered before you meet your deductible?</p>	<p>Yes. Does this plan provide Minimum Essential Coverage? Yes

Peg is Having a Baby
(9 months of in-network pre-natal care and a hospital delivery)

- [Diagnostic test](#) (*blood work*)
- Prescription drugs
- [Durable medical equipment](#) (*glucose meter*)
